- The Portuguese power generation industry had total revenues of \$10 billion in 2022, representing a negative compound annual growth rate (CAGR) of 2.3% between 2017 and 2022.
- Industry production volumes declined with a negative CAGR of 1.9% between 2017 and 2022, to reach a total of 50.3 TWh in 2022.
- Portugal had one of the lowest quarterly average prices in Europe in Q4 2022. This is attributed to the cap introduced by the country's government on gas prices for electricity generation in June 2022.
