- The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$12 billion, equivalent to 28.3% of the market's overall value.
- Non-life insurance coverage in the Spanish population is moderate. According to in-house research, in 2022, Spain's non-life insurance penetration (ratio of premiums to GDP) stood at 3%.
