The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The Spanish Make-Up market had total revenues of \$736.0 million in 2022, representing a compound annual growth rate (CAGR) of -1.9% between 2017 and 2022.
- Market consumption volumes declined with a CAGR of -4.1% between 2017 and 2022, to reach a total of 59.8 million units in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.2% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$861.8 million by the end of 2027.
