- The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$7.6 billion, equivalent to 20.8% of the market's overall value.
- It is widely acknowledged that the frequency and severity of claims are increasing, as seen by recent natural disasters or cyber events. According to data evaluations by Mastercard Cyber Quant, financial hackers, politically motivated cybercriminals, and political activists account for 93% of cyberattacks in Switzerland.
