Summary

The face make-up segment consists of blusher, foundation, face powder and other face make-up products. The lip make-up segment consists of lip liner, lipstick, lip gloss and other lip make-up products. The nail make-up consists of nail polish. The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The Swiss Make-Up market had total revenues of \$344.8 million in 2022, representing a compound annual growth rate (CAGR) of -2.9% between 2017 and 2022.
- Market consumption volumes declined with a CAGR of -4.1% between 2017 and 2022, to reach a total of 26.1 million units in 2022.
- The performance of the market is forecast to decline further but at a slower pace, with an anticipated CAGR of -1.4% for the five-year period 2022 2027, which is expected to drive the market to a value of \$321.5 million by the end of 2027.
