- The road segment accounted for the industry group's largest proportion in 2022, with total revenues of \$5.5 billion, equivalent to 72.1% of the industry group's overall value.
- The Swiss transportation services industry group is hampered by several macroeconomic factors, such as an economic slowdown and a decline in business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in Switzerland declined to 100.81 in December 2022, down from 102.85 in January 2022.
