- The Asia-Pacific Make-Up market had total revenues of \$23,994.5 million in 2022, representing a compound annual growth rate (CAGR) of 5% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.2% between 2017 and 2022, to reach a total of 1,376.6 million units in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.8% for the five-year period 2022 2027, which is expected to drive the market to a value of \$28,961.0 million by the end of 2027.
