- The European non-life insurance market had total gross written premiums of \$612.9 billion in 2022, representing a compound annual growth rate (CAGR) of 4.2% between 2017 and 2022.
- The motor segment accounted for the market's largest proportion in 2022, with total gross written premiums of \$170.2 billion, equivalent to 27.8% of the market's overall value.
- According to in-house research, in 2022, Germany accounting for a share of 24% was the largest European non-life insurance market, followed by the UK and France holding a share of 14.1% and 11.4%, respectively.
