- Industry consumption volumes declined with a negative CAGR of 1.1% between 2017 and 2022, to reach a total of 17,328.1 billion Cubic Feet in 2022.
- The invasion of Ukraine by Russia had a significant impact on the European gas supply in 2022. In the EU, natural gas consumption fell by 13% in 2022 compared to 2021.
