The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The Scandinavian Make-Up market had total revenues of \$1,180.3 million in 2022, representing a compound annual growth rate (CAGR) of 1.2% between 2017 and 2022.
- Market consumption volumes declined with a CAGR of -1% between 2017 and 2022, to reach a total of 101.6 million units in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 3.3% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$1,389.5 million by the end of 2027.
