After seeing only sluggish retail unit volume growth, at best, in the earlier years of the review period, shelf stable fruit and vegetables packaging recorded a spike in demand due to the arrival of the pandemic in 2020, followed by further positive growth in 2021. The previous sluggish or stagnating growth had chiefly been due to a lack of innovation, with players proving reluctant to invest in new pack types in this category as demand for shelf stable fruit and vegetables was weak or even dimi...
