- The Chinese forest products market had total revenues of \$107.9 billion in 2022, representing a compound annual growth rate (CAGR) of 4.0% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.4% between 2017 and 2022, to reach a total of 713.6 million m3 in 2022.
- China accounted for 66.5% market share of the Asia-Pacific forest products market.
