- The travel & tourism industry consists of revenues generated by passenger airlines, passenger rail, hotels & motels, foodservice, travel intermediaries, and casinos & gaming.
- The Hong Kongese travel & tourism industry had total revenues of \$2.9 billion in 2022, representing a negative compound annual growth rate (CAGR) of 45.9% between 2017 and 2022.
- The travel intermediaries segment accounted for the industry's largest proportion in 2022, with total revenues of \$1.3 billion, equivalent to 43.9% of the industry's overall value.
- The growth of the industry is attributed to rising leisure and business tourism, growth in the hotel and motel industry, an increasing number of global events attracting large visitors, boosting infrastructure development, easing mobility, and emerging adventure tourists. For instance, according to GlobalData, the proportion of travel and tourism in the GDP of Hong Kong increased to 1.71% in 2022 from 1.28% in the previous year.
