- The production volumes declined with a negative CAGR of 4.6% between 2017 and 2022, reaching a total of 42,480.7 thousand tonnes in 2022.
- According to the Czech Statistical Office, a majority of the country's exports go to the European Union (EU), with 31.8% of which are going to Germany solely. Fossil fuels have always been a significant component of the energy mix in the Czech Republic and continue to make up the majority of the country's total energy supply and domestic energy production.
