- The Italian metals & mining industry had total revenues of \$18.3 billion in 2022, representing a compound annual growth rate (CAGR) of 3.3% between 2017 and 2022.
- The production volumes declined with a negative CAGR of 2.1% between 2017 and 2022, reaching a total of 21,636.8 thousand tonnes in 2022.
- In 2022, the market fell as mining collapsed in Sicily and Sardinia, where sulfur, lead, and zinc extraction all fell.
