- The Dutch metals & mining industry had total revenues of \$5.2 billion in 2022, representing a compound annual growth rate (CAGR) of 3.5% between 2017 and 2022.
- The production volumes declined with a negative CAGR of 1.9% between 2017 and 2022, reaching a total of 6,183.8 thousand tonnes in 2022.
- The value of the Dutch market declined in 2022 due to market volatility, weak global demand, labor shortage, and rising operational costs.
