- The metals & mining market includes aluminum, steel, iron ore, coal, base metals, and precious metals. Market volume includes production volume and market value is calculated by multiplying market volume with production price.
- The Spanish metals & mining industry had total revenues of \$11.6 billion in 2022, representing a compound annual growth rate (CAGR) of -0.3% between 2017 and 2022.
- The production volumes declined with a negative CAGR of 8.2% between 2017 and 2022, reaching a total of 11,930.9 thousand tonnes in 2022.
- The Spanish industry has suffered in recent years due to the imposition of tariffs on several EU products, including steel, by US President Donald Trump in 2018. This has contributed to a decline in the production of metals.
