- The Swedish travel & tourism industry had total revenues of \$19.7 billion in 2022, representing a negative compound annual growth rate (CAGR) of 2.7% between 2017 and 2022.
- The hotels & motels segment accounted for the industry's largest proportion in 2022, with total revenues of \$4.6 billion, equivalent to 23.5% of the industry's overall value.
- The growth of the industry is also attributed to rising leisure and business tourism, growth in the hotel and motel industry, an increasing number of global events attracting large visitors, boosting infrastructure development, easing mobility, and emerging adventure tourists. For instance, according to GlobalData, the proportion of travel and tourism in the GDP of Sweden increased to 2.26% in 2022 from 1.25% in the previous year.
