- In 2022, the UK home & sgarden products market experienced contraction due to smartphone saturation and reduced consumer spending. The economic slowdown and inflation contributed to decreased consumer spending in retail, resulting in a dip in the market. For instance, consumer price inflation in the UK in 2022 stood at 9.1%, an increase from 2.7%, according to GlobalData.
