- The travel intermediaries segment accounted for the industry's largest proportion in 2022, with total revenues of \$7.9 billion, equivalent to 40.6% of the industry's overall value.
- The market witnessed strong growth of 38.6% in 2022 due to rising leisure and business tourism, growth in the hotel and motel industry, an increasing number of global events attracting large visitors, boosting infrastructure development, easing mobility, and emerging adventure tourists.
