- The European Syrups & Spreads market had total revenues of \$14,255.1 million in 2022, representing a compound annual growth rate (CAGR) of 4.2% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2.1% between 2017 and 2022, to reach a total of 1,936.9 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.7% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$17,109.3 million by the end of 2027.
