- The North American Spirits market had total revenues of \$144,667.2 million in 2022, representing a compound annual growth rate (CAGR) of 5.7% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 11.2% between 2017 and 2022, to reach a total of 7,308.7 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 7.3% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$205,297.0 million by the end of 2027.
