High inflation rates and the cost-of-living crisis in the UK in 2022 were adversely impacting volume sales of confectionery. Both chocolate and sugar confectionery products are generally considered discretionary expenses, which UK consumers sought to constrain against a backdrop of shrinking disposable incomes. This drove declines in packaging unit volume sales of the major pack types in the category, such as flexible plastic and aluminium foil.
