After seeing dynamic growth in 2021, in 2022 packaging volumes of confectionery turned to slight decline, returning to around the pre-pandemic level. Chocolate confectionery and gum continued to see rising packaging volumes in 2022, although sugar confectionery turned to decline after an exceptional year in 2021, which negatively impacted packaging volumes of relevant pack types, such as aluminium foil and flexible aluminium/paper.
