Retail unit volume sales of hot drinks packaging declined for the second consecutive year in Spain in 2022, bringing down retail unit volumes of its two main pack types, folding cartons and flexible plastic, although folding cartons continued to gain pack type share in the market, largely due to its sustainability credentials. One reason for the falling retail sales is the competition from foodservice, which continued its recovery from the shocks dealt by the COVID-19 pandemic in 2020. Furthermo...
