In 2022, brick liquid cartons remained the leading pack type for plant-based milk, the largest category in plant-based dairy in Japan. On the other hand, shaped liquid cartons remained a small, but growing niche as a packaging alternative. The popularity of brick liquid cartons is mainly due to being typically manufactured from a single sheet of paperboard, which is considered more cost-effective compared to shaped liquid cartons, which require multiple layers of materials.
