In 2022, sauces, dips and condiments packaging saw negligible overall growth. Many pack types saw decline, such as other plastic jars, mainly used for herbs and spices, and others seeing growth, including flexible aluminium/plastic, mainly used for liquid recipe sauces (excluding pasta sauces). Glass jars was one pack type that managed to maintain fairly stable sales in the category overall, but saw share growth in salad dressings in particular, therefore eating into the share of the dominant pa...
