Soft drinks packaging total unit volumes continued to grow in 2022 for the second consecutive year in Singapore following the sharp fall in sales due to COVID-19 in 2020. While retail sales actually managed to record a minimal increase in 2020, and have been seeing positive annual growth rates since then, foodservice sales saw a major decline in 2020, due to outlet closures. In spite of strong foodservice growth in both 2021 and 2022, the channel's unit volumes still remain well below their 2019...
