Cafes/bars saw steady decline in the number of outlets during the review period, which continued throughout 2023. The biggest problem is within independent bars/pubs, which is home to a persistent fall in the large number of traditional Dutch pubs and brown cafes (bruine kroegen) - so-called thanks to traditional interiors with dark wood panelling. These brown cafes cater mainly to a 60+ consumer base which is a declining demographic in the Netherlands. Another challenge is that the formats tend...
