This was partially due to the normalisation of consumer behaviour, following the eat-in boom experienced in the aftermath of the pandemic. Demand was also impacted by inflationary pressures, as players such as Shakey's Pizza Asia Ventures Inc, faced with rising input costs, were forced to increase their prices, or create more affordable dishes in an attempt to retain...
