Positioned in high consumer traffic locations, street stalls/ kiosks performed the worst during the COVID-19 pandemic. In a highly fragmented channel, mainly represented by individual entrepreneurs, adaptation to COVID-19 restrictions was difficult, with a significant reduction in the number of consumers on the streets, and the cancellation of events and popular festivals, leading to a considerable current value decline.
