The Russia Automotive Engine Oils Market size is estimated at 470.22 Million Liters in 2024, and is expected to reach 476.5 Million Liters by 2026, growing at a CAGR of 0.67% during the forecast period (2024-2026).

Key Highlights

- -Largest Segment by Vehicle Type Commercial Vehicles : The highest engine oil consumption in the commercial vehicles sector of the country is attributed to the high engine oil requirements for commercial vehicles in Russia.
- -Fastest Segment by Vehicle Type Passenger Vehicles: The expected recovery of the production and sales of passenger vehicles in Russia from 2021 is anticipated to boost the engine oil consumption during the forecast period.

Russia Automotive Engine Oils Market Trends

Largest Segment By Vehicle Type : Commercial Vehicles

- In Russia, engine oils account for the major share of automotive lubricants. During 2015-2019, engine oil consumption in Russia recorded a negative CAGR of -0.31%. The decreasing annual mileage of automobiles in the country and the growing penetration of synthetic lubricants have been the key factors leading to the decline in automotive engine oil consumption.
- In 2020, the COVID-19 outbreak resulted in a massive decline in the usage rate of the existing vehicle fleets in the country and caused a 16.13% drop in engine oil consumption.
- The re-employment of lockdowns due to the second wave of COVID-19 and the country's declining active motorcycle population

are likely to negatively impact engine oil demand. However, the growing passenger vehicle population and activity in the commercial vehicles segment are projected to increase engine oil consumption in the next five years.

Russia Automotive Engine Oils Industry Overview

The Russia Automotive Engine Oils Market is fairly consolidated, with the top five companies occupying 79.33%. The major players in this market are DelfinGroup, Gazprom, LUKOIL, ROSNEFT and Royal Dutch Shell Plc (sorted alphabetically).
