In 2023, laundry care saw a decline in retail volume growth as retail value sales were bolstered by rising inflation and high price points. Furthermore, as hygiene concerns diminished following COVID-19, Irish consumers were returning to pre-pandemic routines, reducing the frequency of their cleaning. Moreover, rising prices decreased demand for non-essential products, including starch/ironing aids, with consumers using fabric softeners and 2-in-one products, such as Bold with built-in Lenor.
