- The G8 countries contributed \$38,189.5 million in 2023 to the global air freight industry, with a compound annual growth rate (CAGR) of -1% between 2019 and 2023. The G8 countries are expected to reach a value of \$47,190.7 million in 2028, with a CAGR of 4.3% over the 2023-28 period.
- Among the G8 nations, the US is the leading country in the air freight industry, with market revenues of \$17,765.9 million in 2023. This was followed by Germany and Japan, with a value of \$6,940.1 and \$5,504.1 million, respectively.
- The US is expected to lead the air freight industry in the G8 nations with a value of \$20,988.1 million in 2028, followed by Germany and Japan with expected values of \$8,571.9 and \$7,366.2 million, respectively.
