- Brazil, Russian Federation, India and China (BRIC) are the emerging and fast growing countries within the air freight industry and had a total market value of \$15,197.7 million in 2023. China was the fastest growing country with a CAGR of 6.3% over the 2019-23 period.
- Within the air freight industry, China is the leading country among the BRIC nations with market revenues of \$13,982.8 million in 2023. This was followed by Brazil, India and Russia with a value of \$977.2, \$222.3, and \$15.4 million, respectively.
- China is expected to lead the air freight industry in the BRIC nations with a value of \$21,645.5 million in 2028, followed by Brazil, India, Russia with expected values of \$1,394.6, \$287.1 and \$16.9 million, respectively.
