- The G8 countries contributed \$159,202.4 million in 2023 to the global paper & paperboard industry, with a compound annual growth rate (CAGR) of 3.8% between 2019 and 2023. The G8 countries are expected to reach a value of \$199,020.4 million in 2028, with a CAGR of 4.6% over the 2023-28 period.
- Among the G8 nations, the US is the leading country in the paper & paperboard industry, with market revenues of \$83,924.6 million in 2023. This was followed by Japan and Germany, with a value of \$23,310.2 and \$16,885.2 million, respectively.
- The US is expected to lead the paper & paperboard industry in the G8 nations with a value of \$106,100.0 million in 2016, followed by Japan and Germany with expected values of \$31,143.5 and \$19,768.3 million, respectively.
