- Within the paper & paperboard industry, China is the leading country among the BRIC nations with market revenues of \$128,437.5 million in 2023. This was followed by India, Brazil and Russia with a value of \$17,683.2, \$6,102.3, and \$3,528.0 million, respectively.
- China is expected to lead the paper & paperboard industry in the BRIC nations with a value of \$173,808.8 million in 2028, followed by India, Brazil, Russia with expected values of \$21,911.3, \$7,937.9 and \$3,831.7 million, respectively.
