Notable price increases in retail tissue in Denmark in 2023 were driven by cost inflation covering aspects like energy, material sourcing, labour, logistics and supply chain constraints. Price increases were consistent with the movements across tissue and hygiene in the country, and more broadly with the general economy. Overall, in retail tissue, price increases pushed strong retail current value growth at the end of the review period, with a more moderate retail volume increase.
