Following a surge in demand at the height of the pandemic due to prolonged home seclusion, demand for sauces, dips and condiments, and therefore associated packaging, started to stabilise in 2021 with further volume declines being recorded in 2022 due to greater mobility outside of the home. Nevertheless, retail volumes in terms of packaging units for this category, including for pickled products, remained above pre-pandemic levels in 2022.
