In a repeat of 2021's weaker performance, the decline in retail unit volumes of sauces, dips, and condiments packaging in 2022 in the Netherlands was due to a stabilising of demand following the stockpiling witnessed in 2020 due to pandemic-related home seclusion. Therefore, greater time spent outside of the home is placing pressure on stronger demand for these products, in addition to shifting consumer preferences and lifestyle changes.
