Although sauces, dips and condiments are appreciated for the convenience they add to home cooking, volume sales in the category were flat in 2022 due to high price increases. Supply chain disruptions due to the Russia-Ukraine war and global economic uncertainties put pressure on consumers' incomes and constrained volume growth in the category. As a result, packaging unit volumes in sauces, dips and condiments were seeing stagnating sales in 2022.
