- The South African Beer & Cider market had total revenues of \$7,356.4 million in 2022, representing a compound annual growth rate (CAGR) of 9.5% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 4% between 2017 and 2022, to reach a total of 4,575.4 million liters in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 7.8% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$10,693.3 million by the end of 2027.
