- The Brazilian Beer & Cider market had total revenues of \$37,708.0 million in 2022, representing a compound annual growth rate (CAGR) of 8.3% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2.8% between 2017 and 2022, to reach a total of 14,948.9 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 8.9% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$57,874.5 million by the end of 2027.
