- The Brazilian Oral Hygiene market had total revenues of \$3,044.4 million in 2022, representing a compound annual growth rate (CAGR) of 6.4% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1% between 2017 and 2022, to reach a total of 1,615.5 million units in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 4.2% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$3,740.3 million by the end of 2027.
