- The Singaporean Oral Hygiene market had total revenues of \$101.1 million in 2022, representing a compound annual growth rate (CAGR) of 1.7% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0.5% between 2017 and 2022, to reach a total of 16.1 million units in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.8% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$116.3 million by the end of 2027.
