The market is valued according to retail selling price (RSP) and includes any applicable taxes. All currency conversions have been made using constant annual average 2022 exchange rates.
- The Singaporean Soups market had total revenues of \$16.4 million in 2022, representing a compound annual growth rate (CAGR) of 4.6% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 2.6% between 2017 and 2022, to reach a total of 2.7 million kilograms in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 2.3% for the five-year period 2022 2027, which is expected to drive the market to a value of \$18.4 million by the end of 2027.
