All currency conversions used in the creation of this report have been calculated using constant annual average 2022 exchange rates.
- The French Beer & Cider market had total revenues of \$15,894.0 million in 2022, representing a compound annual growth rate (CAGR) of 2.2% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0.8% between 2017 and 2022, to reach a total of 2,272.5 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.1% for the five-year period 2022 2027, which is expected to drive the market to a value of \$20,361.6 million by the end of 2027.
