- The German Beer & Cider market had total revenues of \$34,473.6 million in 2022, representing a compound annual growth rate (CAGR) of 1.2% between 2017 and 2022.
- Market consumption volumes declined with a CAGR of -1% between 2017 and 2022, to reach a total of 7,895.3 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 7.2% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$48,786.9 million by the end of 2027.
