- The Dutch Pet healthcare market had total revenues of \$345.0 million in 2022, representing a compound annual growth rate (CAGR) of 3% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 0.8% between 2017 and 2022, to reach a total of 32 million units in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 1.8% for the five-year period 2022 2027, which is expected to drive the market to a value of \$377.2 million by the end of 2027.
