- The North American Oral Hygiene market had total revenues of \$10,466.7 million in 2022, representing a compound annual growth rate (CAGR) of 3.7% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.8% between 2017 and 2022, to reach a total of 2,914.9 million units in 2022.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 3.4% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$12,356.6 million by the end of 2027.
